

EQUESTRIAN EXHIBITOR PARKING
MARIAN COLLEGE GROUNDS
- TERMS & CONDITIONS -

1. Parking will be granted to Equestrian Exhibitors in Marian College on the condition that the owner complies with the regulations and orders of the stewards and attendants in charge of the premises. In the event of the holder's non-compliance, the ticket may be cancelled, and the holder asked to remove his vehicle from the premises.
2. The ticket issued must be displayed on the vehicle at all times and is non-transferable.
3. The premises will be open from 3pm on Monday 4 August until 12 noon on Monday 11 August. Vehicles remaining on the premises outside of this period will be subject to a fine of €50 a day.
4. No dogs, horses or any other animal is allowed on the premises.
5. Occupiers of vehicles are requested to assist in keeping the premises tidy and clean and to place all the litter in the bins provided. Under no circumstances can any vehicle be 'mucked out' anywhere within the confines of the premises.
6. Gas barbeques only, no open fires.
7. Hook-up to electricity is not available onsite. Exhibitors staying in lorries may use a generator but there will be a strict 11pm curfew in place for generator usage.
8. Shower and toilet facilities are available onsite.
9. No vehicle will be permitted to move freely within the grounds. Vehicles must be parked in the allocated space until final departure. Parking jeeps with trailers is permitted on a limited basis, and the RDS should be notified in advance. Please note Marian College will not be used as a parking facility from which to come and go. It is a one-time only entry for the jeep and trailer; jeeps will remain stationary with the trailer for the duration of the stay at the Show.
10. Marian College is predominantly a hard gravel surface which is not suitable for camping / tents. Camping is strictly prohibited.
11. Occupants of vehicles are asked to cooperate with security staff at all times.
12. If there are insufficient bookings the RDS reserves the right to cancel the parking arrangements. Should such circumstances arise, a full refund will be made.
13. Neither the Society nor any of its Officers, Officials or Servants shall be in any way responsible or accountable for anything that may happen (from any cause or circumstance whatsoever) to a vehicle owner or their servants, or agents, or to any vehicle or property brought onto the premises. The Society shall not, in any way, be responsible for, or accept any liability for vehicles left on the premises after 12 noon on Monday 11 August. Each vehicle owner shall be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, or arising from any vehicle, and shall indemnify the Society against all legal or other proceedings in regard thereto and take out appropriate insurance cover for this purpose.
